

Oakland Interfaith Gospel Choir Participant & Volunteer Agreement

I understand that to be fully registered as an active participant in any activity and ensembles under the Oakland Interfaith Gospel Choir (OIGC) organization:

_____ I have read and will adhere to all attendance and participation requirements

_____ I have read and will adhere to the dress code appropriate to the group with which I sing

_____ I have completed my profile on Chorus Connection, and will maintain it as current

_____ I have read and will follow OIGC's Code of Conduct, treating myself and others with respect

_____ I will pay my dues via Chorus Connection, or set up a payment plan to do so

_____ I understand that my participation is implicit permission for OIGC to use any images in photos and video in perpetuity. I give consent for my and/or my child's image, voice, and artwork to be used in association with publicity, fundraising, and community activities exclusively on behalf of OIGC.

_____ I understand that OIGC practices full disclosure of program revenue sources, and I may request such information at any time or access public information through resources such as GuideStar.

_____ I understand that publicity and income in support of OIGC is earned through performances of the various ensembles in our family of choirs. I consent to OIGC receiving payments for performances involving myself and/or my child which may include concerts, commercials, films, radio, community events, billboards, internet presence, flyers, and newspaper or television appearances. I understand I am not eligible for compensation.

_____ I have read and understand OIGC's Conflict of Interest policy. I agree to abide by this policy by immediately declaring any potential conflicts as they may arise.

_____ I have read OIGC's Confidentiality and Nondisclosure policy. I agree that I will not use or disclose any proprietary or confidential information I may obtain to any party other than is required as part of my role with OIGC, and that I will take reasonable care of any OIGC property and return it upon request or conclusion of the task for which I received said property, whichever occurs first.

_____ I acknowledge that I have read the Handbook and acknowledge the contents within. I am aware that the OIGC Handbook is a living document, that I will be notified when the Handbook is updated, and that the most current version of this document will remain publicly available on OIGC's website. www.oigc.org/governance

_____ I agree that any dispute concerning, arising from, relating or referring to the subject matter of this Agreement shall be resolved exclusively by binding arbitration in the state of California, according to the rules of the American Arbitration Association, unless OIGC and I agree in writing to resolve the dispute in a different forum.

Health

_____ I have read and understand the physical requirements outlined under Health Considerations in the Handbook. I commit to personal responsibility for my physical health and well-being, and I understand that I may request reasonable accommodation in advance. I also understand that OIGC may not be able to meet my request.

_____ I understand that OIGC follows Federal and State Public Health guidelines. I understand OIGC will consult with medical, health, safety, and emergency management experts in determining responses related to COVID-19 or any other significant health issue, and that these may change at any time. I understand that the most current information will be posted publicly at www.oigc.org/governance.

_____ I agree not to attend any in-person event if I have any symptoms of illness, particularly COVID-19; or if I have been in close contact with someone diagnosed with COVID-19 in the last 14 days; or if I have self-identified as unwell.

_____ I agree that if I develop symptoms consistent with COVID-19 and/or test positive for COVID-19, I will immediately inform OIGC by emailing health@oigc.org.

By signing this form, I understand that failure to adhere to the policies and commitments above may subject me to appropriate actions by OIGC up to and including suspension and/or expulsion from the organization. I further agree that through my participation, I knowingly assume all risks related to participation at any OIGC activity and will hold OIGC harmless for any and all damages. I understand that I will be asked to review the contents of the Handbook and sign this agreement annually.
